Pricing Elements – Bank Validation

This document provides details of the pricing for our Bank Validation service.

Pricing Structure

There are two cost options for this service as follows:

- Per Lookup where credits for a defined number of lookups are committed to in advance and are valid for 12 months. On expiry of the lookups, there is an option to purchase additional credits.
- Annual Licence Where a fixed cost is available for access to the service within a 12-month period. This is more cost effective for Buyers who are likely to use more than 250,000 lookups with 12 months

On-boarding costs

There are no additional costs for the On-boarding for this service unless in the unlikely event on-site training, installation or bespoke development is required which is charged at a rate of £1,200 per day and quoted in advance.

Off-boarding costs

There are no charges for Off-boarding, the service will cease to be live at the end of the contract and no data is stored that will be required to be extracted.

On-going/License/Subscription Costs

There are no on-going License/Subscription Costs other than those defined in this document.

Training & Support

Our services are simple to install and use and we provide training and support by a combination of email, online meeting, or telephone free of charge.



Pricing List

The service can be purchased on a per lookup basis or an annual licence allowing a maximum number of lookups per annum.
