1.1. Purpose

This document explains the pricing applicable to services provided by Tecknuovo available via the G-Cloud 13 Framework, Lot 3 Cloud Support.

1.2. Pricing

Tecknuovo's pricing for all G-Cloud 13 support services is structured on a time and materials charging model and is based on the applicable SFIA (Skills for the information age) rate card, which is available as a separate document published on G-Cloud 13, Digital Marketplace, and as shown in the table below:

Our consultants are assigned to projects and service provisions at the appropriate rate per person per day in our SFIA rate card document. Tecknuovo's SFIA rates are matched with the levels of responsibility and areas of competency as described in SFIA definitions. The rates quoted on our SFIA rate card represent the maximum price for each of the levels and areas.

The total pricing for each service or project is based on the specific needs of our customers. We can provide cost estimates if a customer wishes to purchase a number of our services as a single package.

1.3. Assumptions

Below are pricing assumptions:

- Consultant's working day 8 hours exclusive of travel and lunch
- Working week Monday to Friday excluding national and bank holidays
- Office hours 09:00 to 17:00, Monday to Friday
- Travel, mileage, subsistence included in day rate within M25. Payable at department's standard T&S rates outside M25
- Mileage As above
- Expenses excluded in day rate. These include accommodation and subsistence expenses incurred by Tecknuovo. Payable at Department's standard T&S rates
- Professional indemnity insurance included in day rate
- Account management and customer support part of our overall service provision and no additional costs will be charged for these added value services
- VAT all rates quoted in our SFIA rate card are exclusive of VAT

1.4. Discounts

Tecknuovo's SFIA rate card does not include any volume or combination discounts. We offer a volume discount based on annual contract spend. Discounts are applied to fees that fall within each of the following bandings:

Band	Annual spend	Discount
1	£3 million – £9 million	1.5%
2	£9 million – £15 million	2%
3	£15 million +	3%

e.g., an annual spend of £10 million would get a discount of 1.5% on £6 million (band 1) and a 2% discount on £1 million (band 2).
