Standards for consultancy day rate cards

Consultant's Working Day – 8 hours exclusive of travel and lunch.

Working Week – Monday to Friday excluding national holidays.

Office Hours - 09:00 to 17:00 Monday to Friday.

Out of hours working- Professional services time incurred out of hours is charged at a higher rate as follows:

- Outside of office hours Monday to Friday – 1.25 times the listed rate.
- Saturdays and Sundays - 1.5 times the listed rate.
- National holidays- 2 times the listed rate.

Unless in exceptional circumstances, scheduling out of hours working requires a minimum of 2 weeks prior notice.

Travel and Subsistence – Included in day rate within M25. Payable at department's standard T&S rates outside M25. Where possible, we will agree a sensible approach per project.

Professional Indemnity Insurance – Included in day rate.

Billing – Unless otherwise agreed with the customer, professional services work will be billed monthly in arrears. The minimum billable increment of professional services is half a day.
