Customers need to purchase the mandatory Apex Core business package. Any of the other packages listed below are optional and extend the business capabilities of the Apex solution.

Note ¹ - for assets in 'Band E', Buyers will configure their services using multiples of the above, based on requirements. Enterprise style deals and time-limited discounts may be available.

Note ² - The annual costs include the integration and supply of the third-party Sava Intelligent Energy Essential energy rating software. An upgrade to Intelligent Energy Standard is available on request. The third-party Sava licence is calculated based on an allocation of 70% of the total asset numbers for energy rating purposes, this can be adjusted based on accurate dwelling / property numbers.

1.7 General Terms and Conditions

The following consultancy services are included within the mandatory Implementation package:

- ∞ Customer on-boarding / induction
- ∞ Solution design
- ∞ Installation / setup of the Apex solution in the Rowanwood Cloud-9 environment
- ∞ Setup of system automation
- ∞ Business configuration services
- Business acceptance testing / support
- Training Services delivered by our business consultants using the customers real life data in a business context through online Zoom or MS Teams

The following services are excluded as they vary depending on individual customer requirements but can be provided as 'Extended Professional Services' on request using the SFIA rate card:

- Business process consultancy services
- ∞ Data cleansing & data migration services
- ∞ Third-party bespoke application integration
- ∞ Extended professional services to assist with fast-track business configuration
- ∞ General business consultancy services

What is included in the service:

- ∞ Implementation services as defined above.
- ∞ The Cloud-9 hosted solution running on Microsoft Azure and supporting a production & test environment.
- ∞ All system and user interfaces are provided within the Core Package.
- $\,\infty\,$ Use of the Apex asset management solution for a minimum contracted period of 36 months.
- ∞ If the customer has reserved the right to extend the service beyond the initial 36 month period, Rowanwood will provide an additional exit plan 8 weeks before the 30 month anniversary.
- ∞ A banded allowance for the number of assets to be stored within the system, with an option to increase the assets for an additional licensing fee.
- ∞ Pricing will be subject to annual increases at the prevailing CPI % rate.
- System upgrades will be included in the annual licence and support fee. Also included is a two day provision for business training services to support each upgrade.
- New modules containing additional functionality for the product will be separate to and sit outside of this contract
 and such functionality added to the system will not form part of this agreement.
- ∞ The standard implementation training services are limited to 6 delegates for the majority of the business courses, there are some online overview courses which can be delivered for up to 20 users. Additional training courses can be provided on request using the SFIA rate card.
- ∞ All onboarding and implementation services are delivered online through the use of Zoom or MS Teams, this helps to minimise the cost to the customer and reduces our carbon footprint.
- ∞ If the Surveying package has been included, the customer will require surveyor user licences within the service. The surveying solution is currently supported against a number of specified Android devices.
- Upon termination of the service, an exit plan will be agreed including data extract arrangements. Where the customer is unable to successfully extract the data themselves this can be provided at an additional cost at the end of the contract, priced as per the SFIA rate card.



- ∞ The implementation services are based on a standard implementation scope and duration and includes Project Management, Configuration Consultancy and Training.
- ∞ Rowanwood reserve the right to increase our prices at the call-off contract stage if third party providers have increased their costs.
- ∞ All pricing is exclusive of VAT.
