Pricing

- Professional Services
 - Services will be priced per the attached SFIA Rate Card
- Mechanism
 - Various pricing mechanisms are available depending on the nature of the engagement.
- Assumptions
 - The daily rates are based on the following assumptions:
 - Rates are exclusive of VAT.
 - Consultant's Working Day is eight hours exclusive of travel and lunch.
 - Working week is Monday to Friday excluding national holidays.
 - The rates are valid for a period of 12 months from the Effective Date of the G-Cloud 13 framework agreement.
 - The rates are subject to the availability of suitably-skilled resources.
 - Travel and subsistence within 20 miles of a clients head office is included in the day rate. Travel and subsistence outside of this boundary is payable at the Contracting Body's standard policy rates.
 - In situations where, by mutual agreement between Spotpush Associates and the Contracting Body, the rate card is used for Fixed Price deliverables a premium may be added to reflect the requirements of such an arrangement.
 - The Contracting Body should handle the Charges and terms on individual Call-Off Orders as commercially sensitive.



Pricing

- Volume discounts
 - £1m-£2m 1.75%,
 - £2m and above 3.5%
 - Volume discounts are based on the following assumptions:
 - The volume discount applies to all effort over and above the threshold of £1,000,000, and where pricing is calculated based on resource-days, in each individual Call-Off Order.
 - The volume discount will continue to apply above the higher thresholds, but for avoidance of doubt these are not cumulative volume discounts. For example, a call-off worth £3,000,000 would benefit from a 1.75% discount on the £1m between £1,000,000 and £2,000,000 (which equates to a discount to the value of £17,500) and a discount of 3.5% for the value above £2,000,000 (which equates to a discount to the value of £35,000). The total discount in this case would be £52,500.
 - Volume discounts apply to work under this Service Description and individual Call-Off Order only and are not retrospective. If a call-off variation is requested, the volume discount would not apply.
