



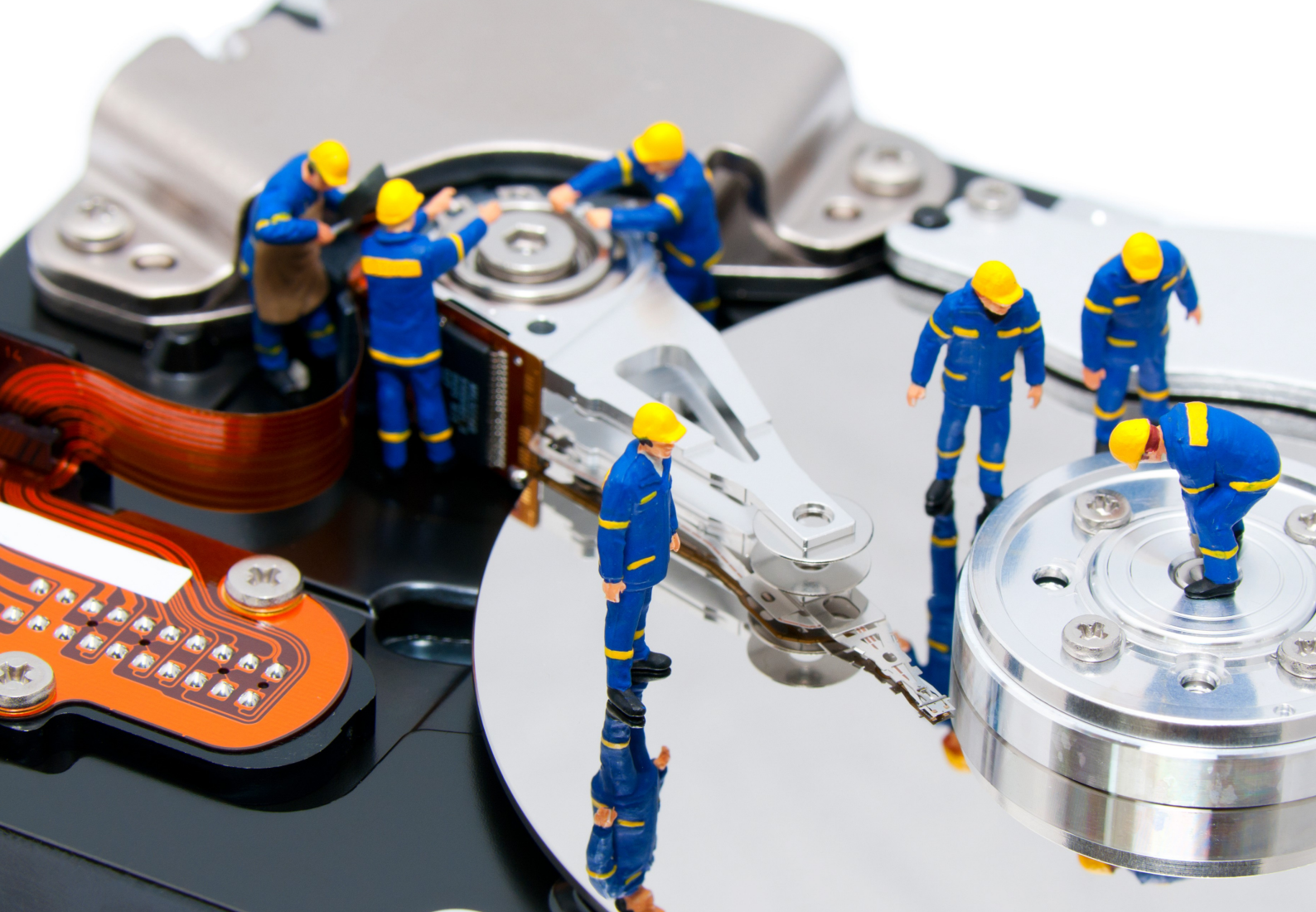

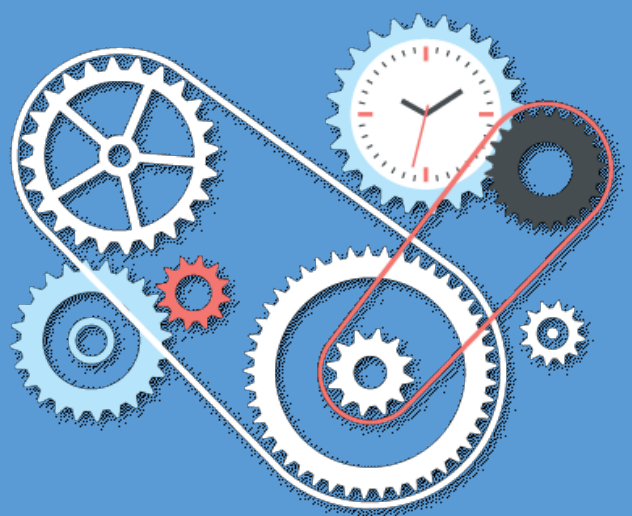

Our audit provides an independent assessment of an organisation's NHS Data Security and Protection Toolkit (DSPT) submission to NHS Digital, as part of the Strengthening Assurance Framework.

The audit is suitable for NHS Trusts (Acute, Foundation, Ambulance and Mental Health), CCGs, ICSs, CSUs, Local Authorities and others seeking an independent assessment.

It's important to check that the assertions made in your DSPT submission are genuine and that there is supporting evidence.

Our DSPT audit service checks a sample of assertions in your submission and helps ensure you are on track.

Our extensive and deep knowledge of information security (and data protection) has been gained through working with a wide range of clients across several industries. This means that we are able to offer constructive guidance on information security best practices, and how to keep information security costs low, whilst minimising any potential disruption when meeting the toolkit requirements.

Process

Our DSP Toolkit Audit projects typically run on the following lines:

- Sign a confidentiality agreement (either clients or ours)
- Organise an initial scoping meeting with the project sponsor so that we can develop an understanding of the client's organisation and IT infrastructure.
- Agree what DSPT controls will be reviewed as part of the scope of work
- Identify what client staff will be contacted as part of the audit
- Determine staff availability and agree the project schedule
- Notify client staff of what we'll be looking to review and gather relevant documentation
- Review documentation prior to audit discussions or meetings, including the selected DSPT assertions declared
- Conduct audit discussions (and/or meetings) and gather evidence
- Analyse findings
- Write report incorporating recommendations and areas of potential improvement
- Issue final report
- Hold debrief meeting with client (if required) to discuss findings and results and record the key lessons learned

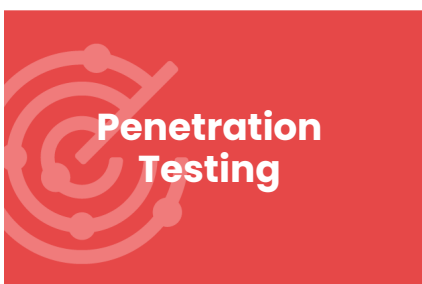
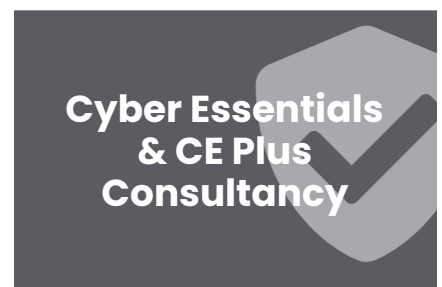
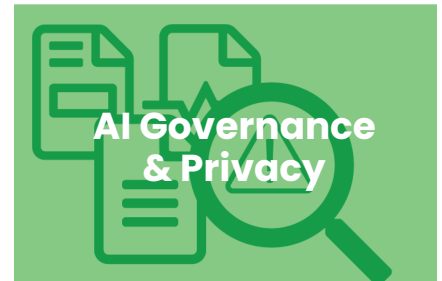
