

What is Atos Prisma Cloud CSPM Service?

Atos Prisma Cloud CSPM Service provides a service wrap to Palo Alto Network Prisma Cloud for the management of cloud risks through the prevention, detection, response, and prediction of where excessive cloud infrastructure risk resides based on common frameworks, regulatory requirements and enterprise policies. Other CSPMs can be supported.

What does it deliver?

Atos Prisma Cloud CPSM Service provides a managed service wrap for Palo Alto Networks Prisma Cloud and other Cloud Security Posture Management (CSPM) solutions. There are four core service elements:

- Asset visibility and assessment
- DevOps Security
- Unified Cloud Security Management
- Continuous Compliance

Additional services are also available.

The benefits to the customer are:

- ▶ It relieves the customer's Security Operations Centre (SOC) team of operating new Prisma Cloud security controls.
- ▶ It avoids the need for retraining the customer's security staff in the detailed operation of the Prisma Cloud platform.
- It allows the full capability of the Prisma Cloud platform to be realised for customers that so not have their own SOC Team or Crowdstrike specialists.
- This service releases in-house staff from operational duties and allows them to focus on business activities which cannot be transferred outside the organisation.
- ► This service can be applied to previously purchased Prisma Cloud solutions, subject to due diligence.
- ► The effective and efficient application of trained Prisma Cloud security specialists to maximise returns from the Prisma Cloud investment in securing the Customer's cloud assets.
- ▶ A managed service that fits with customer needs and risks.
- ▶ This service can be applied to other CSPM platforms.



What technology does it use?

The Atos Prisma Cloud Service is a managed service that utilises the capabilities of the customer's Palo Alto Networks Prisma Cloud platform.



Atos Prisma Cloud Services

The services within the four core service elements are:

What terms apply?

The approach to delivering this service will be agreed with the client following a review of specific requirements and desired outcomes. Services can be tailored to specific business needs. Resources deployed would include Subject Matter Experts; Solution Architects; Technical Architects; Security Analysts; Project Managers and Security Consultants.

In delivering this service, Atos will deploy its local UK and global security expertise as agreed with the customer. UK security services staff are (as a minimum) cleared to BPSS, and additional staff are available with SC and above clearances.

The level and nature of delivery assurance and governance will reflect the type of service engagement and will be mutually agreed by Atos and the client in advance of any paid engagement.

Provision of this managed service is conditional upon the customer procuring the necessary Palo Alto Networks Prisma Cloud software and licences for the duration of the service.

The customer will need to authorise Atos access to the Prisma Cloud management platform for services to manage, build and operate the Prisma Cloud platform.

General G-Cloud 13 terms will apply.

Termination

Termination shall be in accordance with:

- The G-Cloud Framework terms and conditions.
- ▶ Any terms agreed within the Call-Off Contract under Part A Order Form (Termination), where the Crown Commercial Service guidance states: 'The notice period needed for Termination is at least 30 days from the date of written notice for termination without cause.'
- Atos Supplier Terms for this Service are as listed on the Digital Marketplace.

For this specific service, by default Atos ask for at least thirty (30) days prior written notice of termination without cause.

Atos commits to continue to provide the service for the duration of the Call-Off Contract subject to the terms and conditions of the G-Cloud Framework Agreement, the Call-Off Contract, the Atos Supplier Terms and the applicable Third Party Agreements (as defined in the Atos Supplier Terms) related thereto.

How do I order?

Please send your requirements to the email address <u>GCloud@atos.net.</u> We will prepare a quotation and agree that quotation with you, including any volume discounts that may be applicable. Once the quotation is agreed, we will issue you with the necessary documentation (as required by the G- Cloud Framework) and ask you to provide us with a purchase order.

Once we have received your purchase order, the services will be configured to the requirements agreed. If appropriate, you will be provided access to our self-service portal to start provisioning of services.

If you are a new customer, additional 'new supplier' forms may need to be completed.

Invoices will be issued to you and Crown Commercial Services (CCS) (quoting the purchase order number) for the services procured. On a monthly basis, we will also complete the mandated management information reports to Government Procurement.
