The charging for NEC NHSP S4H SaaS and any purchased Optional Module Packages is each made up of an initial on-boarding charge and an ongoing Monthly Subscription Charge. NEC NHSP S4H SaaS and the Optional Module Packages can be taken for an initial term of either 12 months or 24 months.

On-boarding charges

The one off on-boarding charges (covering the on-boarding activities listed in the Service Definition) for NEC NHSP S4H SaaS and any additional Resource requirements for training, which are payable on order, are set out in the table below or the SFIA:

 Provision of URL to access NEC NHSP S4H SaaS. Creation of users and user profiles. Support of the initial cohort data take on, clinic setup and scheduling. Setup and integration of the Screening Equipment for NEC NHSP S4H SaaS. 	An example on-boarding charge for a Trust would consist of a 12 day work package to cover completion of the items in the adjacent column using the following resource profile - Implementation Manager x3 Days @£1,200, Implementation Consultant x9 Days @1,200 = £14,400. A number of factors may impact the makeup of the activities and the overall charge, these include the size of the initial data take-on, any interface configuration, the number and type of equipment to interface etc.	Upon order



Monthly subscription charges

The subscription charge to the client for the NEC NHSP S4H SaaS shall be determined by the number of newborn babies registered and managed through the system in each Screening Year, as set out in the table below. The 'Screening Year' is the twelve-month period commencing on the date of commencement on the order form and annually thereafter. Minimum annual cost £25,000 for up to 10,000 newborns. 10,001+ is priced per registered newborn between the below transactional rate.

10,001+	£2.50 to £3.50 per transaction

Payment is quarterly in arrears.
