1. Pricing

Europa Data Vault supports the following data formats:

GIS formats: GeoPackage, MapInfo TAB*, MapInfo TAB Extended, Esri Shapefile*, Esri File Geodatabase, PostGIS backup

CAD formats: AutoCAD (Real)DWG*, AutoCAD DXF*

Non-spatial formats (for AddressBase): CSV, TSV

If customisation to the data products and/or formats supported by Europa Data Vault is required, this will be quoted for based upon the required number of consulting days using the day rates in the separate SFIA rate card.
