1. Pricing

viaEuropa is the award-winning hosted map and API platform from Europa Technologies. It delivers high quality, fully maintained, digital maps and location data directly to your web applications, desktop GIS and mobile apps.

viaEuropa can be used to consume digital map and geodata from many sources, including Ordnance Survey, Ordnance Survey Northern Ireland, British Geological Survey, HM Land Registry, JBA Risk Management and OceanWise. Further information on products from these sources are included in the appendices of this document. For other datasets, we will work with you to confirm your requirements and provide a quotation using our SFIA rate card prices for the preparation of this data.

The prices presented below exclude all data licence fees and data preparation fees (where applicable). A quotation is provided by Europa Technologies for all services prior to ordering.

viaEuropa services may be purchased by the month or by the year. Quantity discounts are included for annual subscriptions equating to 2 months free. i.e. 12 months for the price of 10.

¹ viaEuropa Solo allows a single user to make unlimited interactive use of viaEuropa services. It may not be used in automated mapping applications. Where multiple users require access to the services, they will each require their own subscription to viaEuropa Solo or an organisational subscription to viaEuropa 5 or above.

Subscribers may use a combination of tile services (WMTS and XYZ), WFS, WMS and API services, where included within a subscription tier.

Any new service type or API introduced to the service will have a published credit cost.

Subscribers exceeding the monthly quota of viaEuropa credits are charged overage for the additional services consumed calculated on a pro-rata basis using their existing tier.

Subscribers can purchase service top-ups at any point during the subscription period. Service top-ups are available in blocks of 10,000 viaEuropa credits. Prices for service top-ups are calculated on a pro-rata basis using the current subscription tier, and benefit from a 10% discount.

Where offline/cached use has been explicitly permitted, the appropriate subscription tier must include an estimate for offline use.

Priority technical support, including out of hours care, is available free of charge to subscribers of viaEuropa Enterprise 100 and above. This includes a dedicated support telephone number. This number is dynamically routed to Europa Technologies office-based staff between 09:00 and 17:30 (UK time), Monday to Friday, and to an on-call mobile at all other times.

Appendix A: Licensing of Ordnance Survey digital map data

viaEuropa includes specific support for digital map data from Ordnance Survey, including OS OpenData, OS VectorMap Local and OS MasterMap. These products are included in the Public Sector Geospatial Agreement (PSGA) and are free at the point of use for members of these agreements. OS OpenData is available for free to all users, subject to conformance with the OS OpenData licence agreement which can be found on the Ordnance Survey website. Organisations not included in the PSGA must be able to demonstrate that they already have the appropriate licence agreements in place before they are able to use viaEuropa services. Europa Technologies can provide a separate quotation for Ordnance Survey data licences where required.

If customisation to the data products and/or viaEuropa service types is required, this will be quoted for based upon the required number of consulting days using the day rates in the separate SFIA rate card.

An itemised quotation for data licence fees and service fees is provided by Europa Technologies prior to ordering.

Appendix B: Licensing of Ordnance Survey Northern Ireland digital map data

viaEuropa includes specific support for digital map data from Ordnance Survey Northern Ireland, including OSNI Largescale vector data. This data and other products are included in NIMA (Northern Ireland Sector Mapping Agreement) and are free at the point of use for members of this agreements. Organisations not included in NIMA must be able to demonstrate that they already have the appropriate licence agreements in place before they are able to use viaEuropa services to consume Ordnance Survey Northern Ireland data. Europa Technologies can provide a separate quotation for Ordnance Survey Northern Ireland data licences where required.

If customisation to the data products and/or viaEuropa service types is required, this will be quoted for based upon the required number of consulting days using the day rates in the separate SFIA rate card.

An itemised quotation for data licence fees and service fees is provided by Europa Technologies prior to ordering.

Support for this data is subject to licensing terms and conditions.

Appendix C: Licensing of British Geological Survey (BGS) data

Where viaEuropa services are to be used to consume BGS geology data, the licences for this data may be procured through this G-Cloud service.

If the appropriate BGS data licences can be shown to be already in place, there may be no need to procure additional licences, although licences must apply for the full duration that the viaEuropa services will be used.

If customisation to the data products and/or viaEuropa service types is required, this will be quoted for based upon the required number of consulting days using the day rates in the separate SFIA rate card.

An itemised quotation for data licence fees and service fees is provided by Europa Technologies prior to ordering.

Support for this data is subject to licensing terms and conditions.

Appendix D: Licensing of HM Land Registry digital map polygons

All viaEuropa users have access to an enhanced version of the INSPIRE polygons dataset.

Where viaEuropa services are to be used to consume an enhanced version of the National Polygon Data (NPD) for England and Wales, subject to terms from HM Land Registry, the licences for this data may be procured through this G-Cloud service.

As this service uses an enhanced version of the NPD, licences to the NPD provided directly by HM Land Registry, or other suppliers, cannot be used.

If customisation to the data products and/or viaEuropa service types is required, this will be quoted for based upon the required number of consulting days using the day rates in the separate SFIA rate card.
