## Overview

**Astun Clarity** enables public sector organisations to deploy a custom cloud based metadata service. Customers include the **Scottish Government, Defra and the Environment Agency** and all their Arms Length Body organisations.

The solution provides both internal metadata maintenance and discovery services with a workflow for quality approval and subsequent publication of a subset of records to [data.gov.uk](https://data.gov.uk) or any other standards compliant portal.

## Pricing

Pricing for Astun Clarity is based upon a customers:

- Volume of records
- Anticipated level of searches
- Extent of customisation required
- Configuration of the service
- The scope of the ongoing support, maintenance service required and expert advisory services we supply directly or via standards committees

Pricing for Astun Clarity is comprised of four key elements:

- Cloud Service Subscription
- Project Management
- Implementation and Training
- Service Enhancements

## Pricing for Cloud Service Subscription

Astun work with their customers to determine their specific requirements for a Cloud Service Subscription and the level of service required:

## Pricing for Project Management, Implementation, Training and Service Enhancements

## **Pricing Conditions**

1. Pre-purchased call-off consultancy days for Project Management, Implementation and Training will be invoiced on receipt of your purchase order.
2. Pre-purchased call-off consultancy days for Service Enhancements will be invoiced on receipt of your purchase order.
3. All Other consultancy days will be invoiced monthly in arrears as these are delivered.
4. The Cloud Service Subscription will be invoiced on receipt of your purchase order and then annually in advance.
5. Minimum contract period 12 months.
6. Orders to pre-purchase consultancy services can include a mix of agreed SFIA levels which can be adjusted within the overall value of the order.
7. Blocks of consultancy services must be called off within 12 months of the date of order, unutilised days cannot be carried forward.
8. Where Project Management is included, this is an illustrative figure based upon the typical duration of a project of this nature. If the project duration is shorter than the illustrative figure, any surplus will be converted into call-off consultancy time. If the actual project duration is longer, a fee of £950 will be payable, for each month or part thereof. If the project duration is longer due to delays by Astun, additional project management fees will be waived.
9. For Consultancy Services delivered at a customer's premises, Travel, Mileage and Subsistence are payable where applicable in accordance with our Service Management details as set out in the Service Definition for these services.
