2. Product Pricing

2.1 Annual Service Fee

The Annual Service Fee is calculated based upon user numbers.

2.2 User-Based Pricing

Pricing is calculated based upon the number of system users, subject to a minimum Annual Service Fee. Each product (see above) requires the purchase of its own set of user licenses.

The Annual Service Fee includes application and database licensing, application and database hosting, software support, maintenance, and upgrades, help desk support, access to all reporting functionality and the right-to-use the API. Additional optional modules may be available, subject to the specific product in question.
