Processing and Production Services: Processing GBs are measured on data volume ingested for processing, after expansion and prior to any filtering such as dedupe, date filter, search terms, etc. Production GBs are measured on the total output size of production deliverables. HST260 (Processing Database Non-Review Storage) is the uncompressed storage footprint of Client Data that is ingested into an Epiq processing database but not promoted to an Epiq hosting database or a third-party application.

RelativityOne: ECA/Repository Workspace: A RelativityOne ECA/Repository Workspace is used for Early Case Assessment and culling documents prior to review. Users can leverage visualizations, searching and certain analytics functions to cull before promoting potentially responsive documents to a Review workspace. An ECA/Repository Workspace cannot exceed 50mm documents, 10,000 unique views per month and cannot exceed 5 concurrent client users at any given time.

Inactive Data Hosting & Services: "Dormant - No User Access" and "Processing" databases require ten (10) business days for reactivation, and Client shall be invoiced at Technical Analyst/Litigation Support rates for all reactivation related labor costs. Separate charges will be made for processing databases, hosting databases and production sets. Client Media Storage charges commence in the fourth calendar month following receipt of such media (i.e., up to three (3) months of storage without incremental billings. Client Media Storage is charged at £38.00 per media per month under SAP Code PRO128. Media transferred to Epiq via sFTP is charged at £7.50 per media per month under SAP Code PRO128F. Any incurred Shipping charges billed at cost.
