Recent examples include:

Effectiveness, Assessment & Investment Appraisal:

Our client had been asked why a life-extension programme should be funded for an existing equipment. We produced an exploratory effectiveness assessment and investment appraisal to create the evidence required to answer that question. We developed an understanding of several possible alternatives whilst providing the client confidence that the Whole Life Costing analysis was sound and robust. A bespoke cost model was developed to work in conjunction with existing client-side tools. We also estimated various commercial implications, segregated fixed and variable costs and highlighted the training and infrastructure challenges brought by investing in new equipment. Our results were presented to our client's scrutiny organisation who were "really happy with what was provided", commending us on the "thorough process and evidence provided to support the decision-making process".

Whole Life Costing throughout the Life:

Our client needed to ensure that their project remained within budget and delivered value for money. Our cost estimating and analysis services were used to gauge the programme's 'should cost' budget, down-select options and identify the commercial strategy. Our work helped the project avoid overspends, deliver value for money and remain accountable. Our client found significant value in our costing process, bringing together siloed thinking and creating a unified vision of the programme. Whole Life Cost Estimating

We have provided Whole Life Cost Estimating services for over three decades, supporting decisions across the investment scale from multi-£Bn programmes to smaller investment projects. When firm prices aren't available, we help you estimate the cost of your investments from cradle to grave (Concept, Design, Manufacture, Operation & Support and Disposal). We cover all cost estimating techniques including bottom-up, analogous and parametric, ensuring that the best technique is chosen for your needs.

We not only help you forecast the cost of individual items, projects or programmes, but also identify any unforeseen costs you may incur and mitigate their probability of occurrence. We ensure that the decisions you make have a robust and holistic financial basis.

Cost Analysis

Reference Class Forecasting

Whether it's a project in its early stages, or an estimate that requires validation, we can use Reference Class Forecasting (RCF) to help improve your thinking.

For projects in their early stages, we can use RCF to help bound your project and give it a robust cost foundation. We use RCF and analysis of trends in other analogous projects to give you an insightful financial assessment that will allow you to set initial budget expectations.

For more mature programmes, we can use RCF as an additional form of validation to our bottom-up cost estimating approach. This can help provide an additional layer of evidence that ensures your decision making is based on the best possible information.

Concept Estimating

We can help you cost ideas from their earliest stages. Often cost and capability drivers and constraints are 'baked in' at the very earliest stages of product or programme development. Using a Systems Engineering approach, we can investigate novel, immature concepts and begin to ground them by providing a holistic assessment of the likely financial and non-financial benefits or disadvantages.

We help you find comparable examples and analyse them for Lessons Learned that benefit your programme. We work with Subject Matter Experts to solidify concepts to make them more explainable.

Verification & Validation

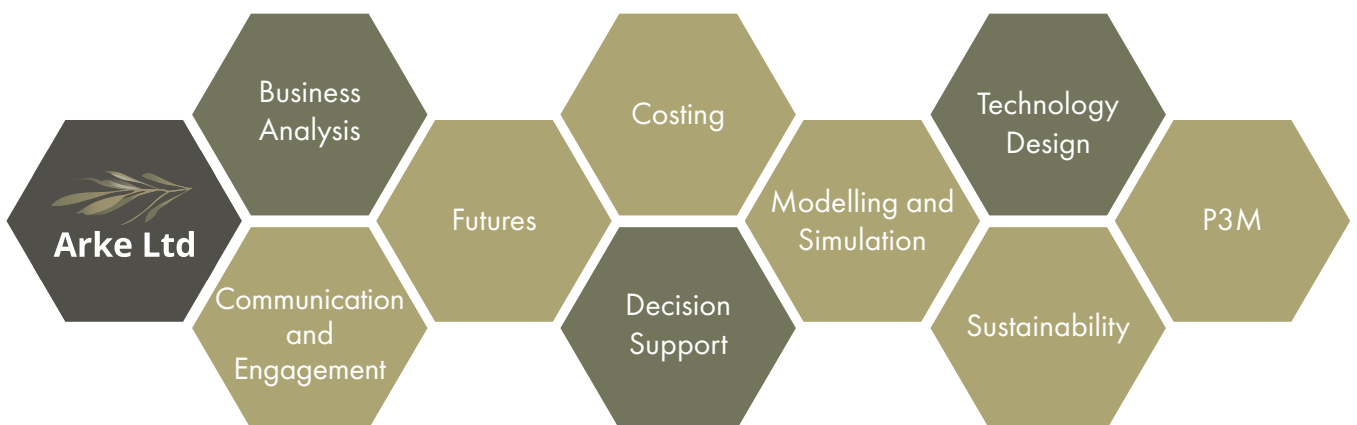
