These can include tabletop exercises and full simulations of different attack types from a number of adversaries, followed by a detailed post-scenario breakdown to establish key learning points and guide the preperation of very tailored and effective training material.

Due to the specificity of training to industry and client contexts, we have found it to be effective for clients to utilise their incident response playbooks and enhance them based on the results.

Leading distributor

Our client invested in a major cloud enabled transformation programme at the heart of which was the requirement for a major transformation IT systems landscape. Moorhouse provided support for the procurement of a strategic ERP cloud platform that would underpin the future operating model.

We defined the end to end procurement process to select vendors, including a cloud capability assessment to form robust partner selection criteria. We identified capabilities and matched these to the requirements for the new ERP platform, helped shortlist vendors against requirements, and managed the governance for the ERP solution and implementation partner vendor selection.

Global Insurer

Faced with an increasingly competitive marketplace, and customer demand for improved digital experiences, the global insurance business undertook a global cloud transformation to embed a suite of new tools.

We defined and managed solution requirements to support delivery of two new digital channels for motor and home customers, reducing calls into the contact centre and boosting C-SAT. We created a formal programme structure, with roles and responsibilities and workstream definitions and defined a detailed rollout plan to ensure benefits realisation in line with the business case.

As a relatively new entrant into the business broadband market, this client needed business analyst capability as they aimed to launch several new digital and hardware products to increase competitiveness in the market.
