## **Pricing Model for the High Cost Drugs System**

## **Basis for charges**

- Pricing is determined by the total population size covered by the commissioner organisation(s) purchasing the system.
- The initial implementation fee is a one off charge and becomes due on the date of commencement of the contract.
- The licence and support charge is an annual charge and becomes due on the System Delivery Date.

Please see appendix on page 2 for scale of charges. These prices are exclusive of VAT.

## **Available discounts**

• Volume discounts are available for customers with more than one Blueteq system.
