iProov makes available to public sector organisations a free evaluation period, during which iProov will provide implementation and solution architecture support for integration and testing. This support is provided in conjunction with a Trial Service Provider, which is the API credentials required to consume the Service.

iProov offers four enterprise packages, geared towards customers with a range of volume scales and operating considerations. The Pro Platinum package in particular is geared towards national-security-level requirements, for implementations with a nation-state scale.

Key Concepts and Definitions

Transaction means a request by API call to an iProov Product for a Token.

- Transaction bundles may be purchased in advance. Any transactions in excess of the numbers purchased in bundles will be billed at the month's end as overage.
- Several Bundles may be purchased and be active concurrently, and overage will only be charged once total transaction volumes have exhausted all available bundle capacity.
- Bundles will be credited from the day on which payment is received.
- Bundles expire 12 months from purchase.

Overage is billed at the below rates per Transaction:

Multi-tenant environment is the default hosting mode for the service, located in the EU.

Single-tenant environment is a hosting mode option where the client can request a hosting instance in any required location (as available) with no other customers able to make use of the same service.

TPS is Throughput Per Second, the rate at which transactions can be initiated. The TPS given is the reserved base-load capacity for the service provided, rather than the maximum capacity.

Per-transaction capacity charge is the charge applicable for each transaction for capacity.

The Capacity Charge is billed at the below rates per Transaction:

Fee and Payment Terms

- 1. Contract length: Minimum three-year initial period.
- 2. Invoice terms: Invoices will be issued for:
 - a. Service package fees, annually in advance
 - **b.** Bolt-ons, in advance upon execution of relevant order form
 - **c.** Transaction Bundles in advance as outlined in the Key Concepts and Definitions above
 - **d.** Per-transaction capacity charge, monthly in arrears.
- 3. Payment terms: Net 30 days from invoice. The client will pay amounts due in the manner reasonably instructed by iProov from time-to-time (e.g. via bank or wire transfer). Any charge to iProov's bank details must be agreed in writing between the parties.
