1. SERVICE DESCIPTION

Business Justification & Financial Analysis 1.1.

Since 2013 our in-house developed software has been used to enable the rapid development of project and programme Business Cases, reporting ROI, Cashflow, P&L and Balance Sheet. With the addition of Social and Climate elements the solution we enable organisation to develop and evaluate decisions across the three dimensions of People, Planet and Prosperity - understanding the impacts and mitigation options for all three simultaneously.

1.2. Social Value Impact

Social Value is a huge area, our inhouse developed software has been developed to take the headache away from organisations by encompassing all the key frameworks and allowing organisations to capture and report social impacts and mitigations in a single place. Industry Templates enable a quick start, and organisations can model holistically or by project, reporting as a company or by specific transformation programme.

1.3. Climate Impact

The demand for transparency of Climate Impact is accelerating and our software enables organisations to capture Climate Impacts, and to align mitigations and offset actions to those mitigations, reporting on the net environmental impact or benefit. 3. REPORTING

3.1. Overview

We bring clarity to an organisation's IT spend by revealing how IT costs are split across services and business units based upon consumption. We use output from performance analyses to determine how the resources within shared infrastructure were being consumed. This data is then combined with financial data taken from the IT budget, historical invoices, HR and finance in our purpose built IT financial management software. Our software creates dashboards revealing which services (and lines of business) are responsible for what IT cost, and critically, assess the cost effectiveness of a single, or a number of, proposed Cloud operating models and solutions. We will build a Business Case assessing when the Cloud investment will pay back, when will the right financial returns be achieved.

Our Social Value Impact and Climate Impact reporting is extensive and ranges from the government PPN 06/20 framework, through to detailed analysis and projections across all three emission scopes and range of social value categories.
