

G-Cloud 14 RingGo Cashless Parking Pricing Document



1. Service Charges

Overview

The RingGo service pricing model is transactional based with costs borne by the End-User or the Client, or a combination of both. The following is indicative of how pricing could be structured but will be dependent on the Client.

Standard Charges to the Client (Option 1)

Where RingGo is the exclusive service provider, under this option we will levy the following charges to the Client, which will be invoiced monthly, in arrears.

Service	Cost to Client
	Excluding VAT
Standard Rate for Transactions / Extensions*	£0.12
Standard Rate per SMS sent*	£0.12
Commission - RingGo Merchant Acquiring	3.00%
Banking - Client Merchant Acquiring	Client pays charges direct to preferred Acquirer

**These charges can be passed on to the End-User or absorbed by the Client.*

Standard Charges to the End-User / Client (Option 2)

Where RingGo is the exclusive provider, under this option we will levy fixed charges directly to the End-User. The use of RingGo Merchant Acquiring is mandatory and will be charged to the Client as follows.

*** These charges are payable by the End-User to RingGo and will be separated from all other parking income that is collected on behalf of the Client.*

Flexible End-User Charges (Option 3)

Under this option, RingGo will implement charges to the End-User based on the market conditions within the Client's car park(s) and/or on-street locations. These fees are paid by End Users directly and retained in full by RingGo.
