Notes:

- 1. A monthly fee contract will run for a minimum of 24 months, to include set up phase, and can be extended in periods of 12 months thereafter.
- 2. If an initial Proof of Concept is required, the monthly fee may take account of set up work undertaken during the PoC.
- 3. The monthly fee will be dependent on the size and complexity of the contract to be held in the software.
- 4. The monthly fee will be dependent on the amount of contract documentation to be added to the document repository and whether this is provided in paper or electronic format.
- 5. The monthly fee will be dependent on whether the software instance is to hold a single contract or a portfolio of contracts.
- 6. The monthly fee is exclusive of VAT which will be charged at the applicable rate.

Data Migration on Expiry or Termination
