Self-Assessment

3 Audit Readiness

- We will require agents to be installed 5 working days prior to the audit and mobile screenshots uploaded
- Provide information of using Teamviewer during sample checks

4 Audit and Remediation

- During audit window our team will assess the 5 technical controls of Cyber Essentials plus programme
- We will have an initial bridge call to run through the schedule, establish POC & escalations and expectations
- CE Assessor will complete sample checks on each machine within the sample set
- CE Assessor will review scan results & Mobile screenshots
- During the audit window we will run scans on request
- If you have not passed the audit during the window our Project team will assign a remediation slot within a suitable time frame
- Any further remediation beyond this would chargeable and would need a review with Account manager .

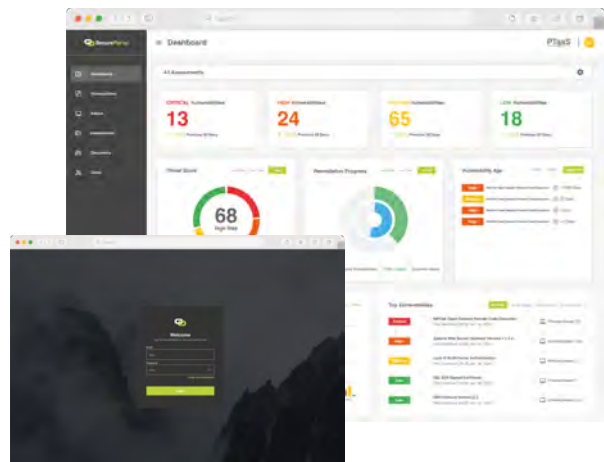
