Cloud Pricing

MRI Contract Intelligence pricing is based upon a number of variables as follows:

- Document Type
 - Commercial Real Estate Lease (Industrial, Office, Retail)
 - Main real estate lease, amendments, annexes, exhibits, certificates, floor plans, addendums, e-mail correspondence, notices, deferrals, and any other tenant related documentation that has extractable information in it for the purposes of lease abstraction
 - Residential Real Estate Lease
 - Main residential real estate lease and any exhibits that have extractable information in it for the purposes of lease abstraction
 - Asset or Equipment Leases
 - Main asset/equipment lease and any exhibits that have extractable information in it for the purposes of lease abstraction
- Region
- Language
- Extraction Format
