1. PRICING

The table below lists the minimum price for a Recurring Advancement Services Program (RASP) contract. Depending on the final mutually agreed scope of the RASP agreement the annual RASP fee will be determined. Therefore, a scoping session is required. Both parties will agree the final price for the initial term, considering complexity of the solution, number, and complexity of any bespoke elements (if any present), the number and complexity of interfaces to third party systems, level of support requested, etc.

Prices are exclusive of possible taxes and exclude possible costs for travel and lodging.

Bentley assumes that work would be done remotely and both parties' endeavour to avoid the need for travel. However, if <USER> insists on Bentley personnel to travel to site, a separate purchase order is required to cover travel time and costs. Bentley will not travel or make any costs for travel without prior written approval from <USER> and a purchase order.

The price listed above will be invoiced annually in advance for each term.

The initial term of Bentley's RASP included within this proposal shall be a minimum of one (1) year in duration. Thereafter, it shall automatically renew for subsequent subscription periods of one (1) year, unless either party gives written notice of its election to not renew at least thirty (30) days prior to expiration of the then-current subscription period.

2. PAYMENT TERMS

Bentley will invoice <<USER>> for the subscription upon receipt and acceptance of a purchase order for the Initial Term, and then annually in advance thereafter.

Invoicing/payment is made annually in advance at the beginning of a term funded preferably from Bentley's cloud services subscription (CSS) budget or offered as an annual fixed fee.

The price of the subsequent Renewal Terms will be the price for the immediately preceding term increased each year by CPI-W All-Items UK value at the time of plan renewal.

Recurring Services will be delivered remotely. If required and applicable, Bentley will invoice actual expenses incurred in the performance of the proposed services and travel time according to the G-Cloud SFIA rate card in addition to the Recurring Services Fee. These additional costs will require a separate purchase order.
