Our combination of extensive tracing knowledge, the latest technology and accumulated industry leading data, provides you with a market leading tracing and investigation web application.

Whichever business sector you operate in, our portfolio of tracing solutions offers access to a wealth of consumer reference data, enabling you to find gone aways, locate lost customers, conduct debtor tracing, and reunite customers with their assets.



TracelQ provides direct access to some of the most comprehensive consumer and business datasets in the UK; which are continually updated, and many are unique to us. Experian® and Equifax® credit header data is updated every 30 days, with most other data sources being updated more frequently. In addition, we also offer a range of premium datasets, which can significantly enhance tracing and investigation productivity.

Leveraging this data universe with proprietary statistical linking technology in combination with our own unique identifier, LexID®, we resolve, match and manage information for over 56 million UK consumer identities.

The dataset contains c.30 years of history of where consumers have lived, together with any changes in names through marriage or divorce, as well as access to contact details (where available in a GDPR compliant way) for contacting consumers beyond the use of sending a letter.

It is this reference dataset that underpins TracelQ to help establish a single, more holistic view of your customers which can significantly increase the likelihood of tracing and contacting your customers and give greater assurance in making risk-based customer decisions.

TraceIQ allows you to create search templates, which you can save and use again. Search templates enable you to select the datasets you want to use, specify whether they should be automatically searched or 'on click' and preset advanced options to on or off. The system allows you to set-up and manage multiple teams of users and assign search templates to meet their specific needs, giving you complete control over user access and system usage throughout your organisation.

TraceIQ results show the following fields where all datasets are used:

Search Criteria: TraceIQ allows users to search on Name, DOB, Address (full or post code only) or Reverse Search of contact information. The minimum input required is one of the attributes such as Name only or postcode only. The system accepts partial name and DOB searches using wildcards where data is not available.

Associations: The users can search on multiple people to determine whether there is an association between them based on residency information.

Aliases: The system provides results showing previous or other aliases that the individual is known by e.g. change of name on marriage/divorce, to enable customers to trace individuals who may have changed name or are associated with fraud.

Residency: Containing all of the known residency information about an individual at a specific address, the residency section highlights the occupancy period and provides a residency score*, which gives an indication as to the likelihood of the person still living at the address.

The score is calculated based on a number of different weighted attributes and characteristics across all datasets held by LexisNexis Risk Solutions, such as recency dates, property sale date, and linked addresses amongst others.

Occupant: Provides you with names (and phone numbers where available) of all past and present occupants at the address without leaving a credit footprint, this section will list associated individuals first (i.e. people who were/are in residence at the address at the same time as the search subject), who could prove valuable in your enquiries.

Neighbour: This section will identify the closest physical neighbours to the property for use in pro-active research. Phone numbers can be provided if required, and you can specify the number of neighbours displayed up to a maximum of 20.

Address Links: This section will display highly probable address links for the subject and other occupants, created using our linking within our data universe.

Mortality Alert: This provides information obtained from our extensive mortality datasets and will highlight if an individual is deceased.

Legal: This result section will help you to build a picture of a person's financial standing; you will be presented with information from IVA, Bankruptcy, CCJ, DRO and Sequestration records.

Property: You will gain knowledge about the price paid for the property, socio- demographic data, council tax band, property type and you can also utilise our Property Register Search (PRS). PRS is a live search directly linked to Land Registry, which can confirm whether the subject currently owns the property or was the last previous owner or not and whether joint or sole ownership.

Business Search: Enables a search for a UK company entity from Companies House data. The search provides a list of the Directors of the entity and if the Director is a UK resident, the system can further search for

personal email, phone and address details of the individual. TraceIQ searches for directorships by name and date of birth in addition to name and address, to ensure that any alternate business addresses are located.

Reverse Search: TraceIQ has a facility to allow a search where customers can provide minimal contact information such as landline, mobile or email address to find individuals who are associated with those numbers or email addresses. Reverse search on email addresses also accesses the Email Risk data to highlight any fraud risk and social media accounts for those with Email Risk enabled.

Email Risk: Email Risk in TraceIQ helps investigate fraud in the digital era. The service will flag both trusted email addresses and those used in previous instances of fraud. Understanding the associations between a name, an email address and the social media accounts, and any fraudulent activities linked to that email address, is key in building a fuller picture of an identity and clarifying doubts related to a suspicious transaction. Email Risk relies on a contributory database from LexisNexis® Emailage which has 96% coverage globally and 94% coverage of UK email addresses.

Service and Support

The TraceIQ solution is delivered as a Service to users via Web Portal. The number of users is unlimited (subject to license fee) and is scalable to meet your requirements. The system is replicated across dual hot-active data centres providing high availability of at least 99.5%. As the solution is web based, it can be accessed from any location including outside the EU if required, subject to your own data privacy requirements. A limited web service API is also available to perform a search.

User and administrator training are provided by our Education team to ensure your users are making the most of your investment in the tool. Customer support is provided, with UK based staff during normal working hours. Outside of these hours, there is an emergency team who can deal with issues such as service unavailability and user lockouts.

We hold the globally recognised ISO27001 Information Security certification, which acknowledges our framework and procedures for data security and confidentiality are of the highest standard. To sustain this certification our employees are continually trained, and we regularly undertake third party audits to ensure adherence to the stringent security management system.

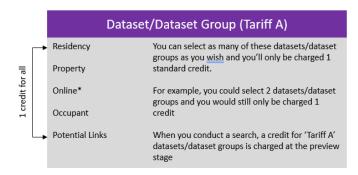

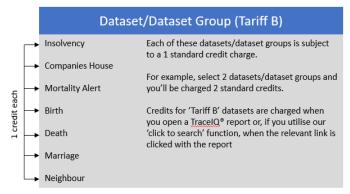
