## Definitions and rate card

### Fees

Typically we provide fixed fee based pricing for defined outcomes that reflect your requirements. We price outcomes based on assumptions around the time we envisage it will take and our MAXIMUM day rates (see next page). This provides a transparent fee structure which we can agree with you.
