2 Pricing Elements and Considerations

The pricing of our service is based on an all-inclusive daily charge rate (excluding VAT at the applicable rate). The scope of the costs cover (but may not be limited to);

3.1.1 Volume Discounts

Our prices are reflected in the SIFA rate card and although we do not offer volume discounts as standard, rate reductions in line with volume bandings can be agreed at the point of engagement.

Volume bandings would typically be 1-5, 6-10, 11-15, 16-20, 21+

3.1.2 Tenure Discounts

Our prices are reflected in the SIFA rate card and although we do not offer tenure discounts as standard, rate reductions for length of service can be agreed at the point of engagement.

Any reduction in pricing will be subject to the contract term being fulfilled. Early termination of services by the buyer will invalidate any discounted rates and services will revert to standard rates that will be payable by the buyer from the commencement of the term.
