1. Published subscription pricing

Foundation – £7,200 per year

Includes one live environment, one test environment, up to 3 connected data sources, up to 2 fraud detection models, up to 5 named analyst or admin users, standard dashboards, alerts and the core analytics library.

Professional – £15,600 per year

Includes all Foundation features, plus up to 8 connected data sources, up to 5 fraud detection models, up to 15 named analyst or admin users, anomaly detection, API access and cross-source pattern analysis.

Enterprise – £28,800 per year

Includes all Professional features, plus up to 20 connected data sources, up to 50 named analyst or admin users, single sign-on, role-based access control, audit export and premium support.

2. One-off setup and activation charges

Service onboarding and activation – £2,000 one-off

Includes initial service setup, baseline configuration and onboarding of up to 3 data sources.

Additional data source onboarding – £450 one-off per source

Applies to each additional data source above the first 3 sources included within the onboarding charge.

3. Optional published add-ons

Additional data source pack – £2,400 per year

Additional analyst user pack – £1,500 per year

Private deployment option – £7,200 per year

Provides a dedicated private deployment for buyers requiring a segregated environment.

4. Included as standard

Role-based access control, standard audit logging and service usage dashboards are included within the service.

Standard software support during UK business hours is included.

Scheduled analytics runs, alerting and rule management are included within the subscribed service entitlement.

5. Pricing assumptions and notes

The annual subscription is billed annually in advance and is based on a minimum contract term of 12 months.

The applicable subscription tier is determined by the data source volume, user entitlement and service options selected by the buyer.
