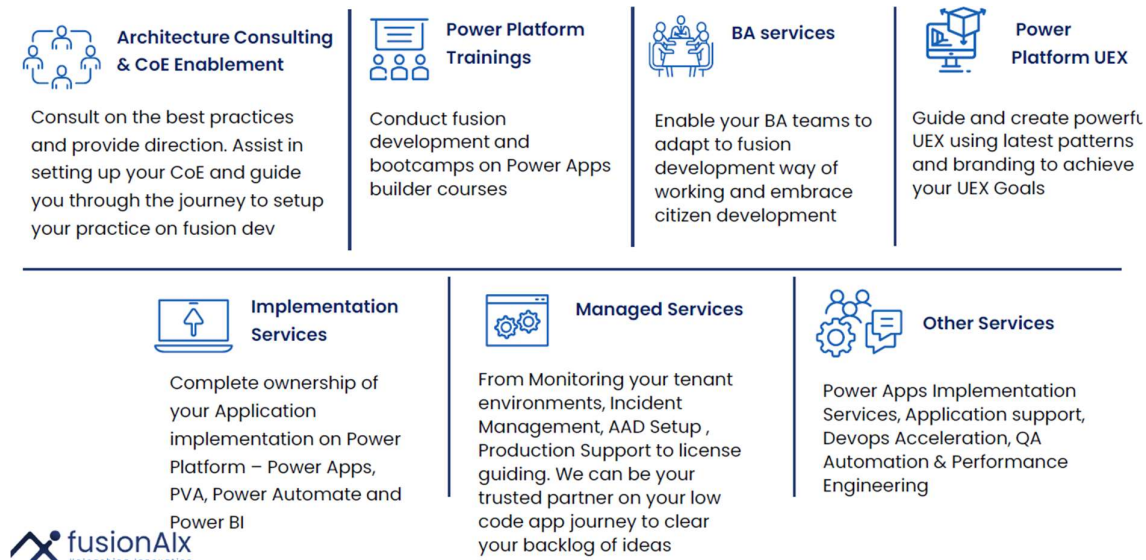
## 1. About Us
