Pricing

The Cority Safety Could Software as a Service solution is priced on the basis of an annual licence fee, which includes the base module cost, and the user licence fee, payable annually in advance.

In addition to annual licence fees, there is an additional one-off implementation fee for companies newly implementing the solution. For the “Safety Essentials Package” – this is a fixed price-engagement for a specific pre-determined scope. For other Safety Cloud modules, the implementation cost would be based on a scoping exercise of the specific needs of the customer and the effort required to implement.

N.B. All implementation would be carried out on the basis of a specific Statement of Work clarifying deliverables.


