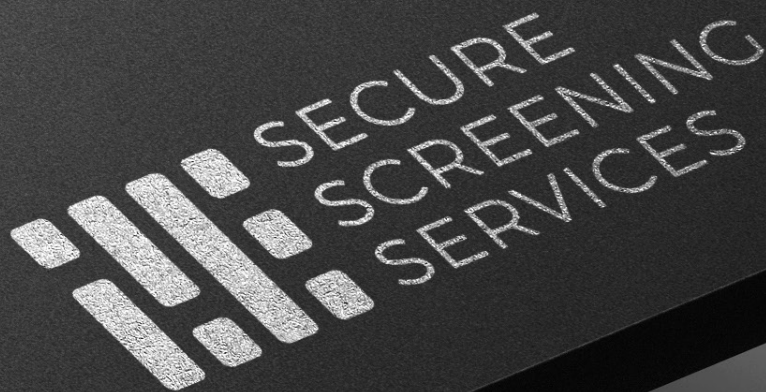

### ID Verification

**£10.00**

This check proves the legitimacy of a candidate by using biometric, facial recognition software in conjunction with documentation to confirm the candidate's identity. In cases where digital verification cannot be completed, a manual verification process is undertaken using a combination of candidate and public data to verify identity.

### Employment History with Gap Analysis

**from £10.00**

This check accumulates the candidate's employment history, including any periods of unemployment. Gap analysis, where required, is included in our employment history check, and incurs no extra cost.

---

### DBS/DS Basic

**£42.50**

This check completes a UK criminal record check and shows unspent convictions and conditional cautions. We conduct our checks using Digital Identity. Your candidates will be automatically selected to conduct their check digitally, saving you time by eradicating the need for face-to-face verification. A basic DBS check will show cautions or convictions that are considered "unspent" under the Rehabilitation of Offenders Act (ROA) 1974.

### DBS Standard

**£47.50**

A Standard DBS check is suitable for certain roles, such as lawyers, accountants, prison workers, and other positions of high responsibility – specifically any role or duty that is listed under the Rehabilitation of Offenders Act (ROA) 1974 (Exceptions) Order 1975. The certificate will contain details of both spent and unspent convictions, cautions, reprimands and warnings that are held on the Police National Computer, which are not subject to filtering.

### DBS Enhanced

**£59.50**

An Enhanced DBS check is suitable for people working with children or adults in certain circumstances such as those in receipt of healthcare or personal care. The certificate will contain the same details as a standard certificate and, if the role is eligible, one or both of the DBS Barred Lists can be checked. An enhanced DBS check can only be requested if the candidate or employee will be involved in a regulated activity. Volunteer role is also available for candidates who are not employed but volunteering in their role, this check can be purchased for £15.00.

---

### UK Credit Check with PEP and Sanctions

**£12.50**

This check includes PEP (Politically Exposed Person) and Sanctions, Court and Insolvency information, CIFAs (Credit Industry Fraud Avoidance) and Watchlist checks. This is a soft check that does not show a candidate's credit score or financial information.

---

### UK Driving Licence Check

**£10.00**

This check validates the authenticity of a candidate's driving license, its validity, and any endorsements or restrictions. Secure Screening Services cross-checks this information with the DVLA (Driver and Vehicle Licensing Agency) to ensure the candidate holds a valid license, ensuring compliance with legal obligations, particularly for roles involving driving.

### Digital Right to Work Check

This service verifies the candidate's legal right to work in the UK. It entails the verification of documents such as passports or Home Office share-codes, carried out digitally in line with Home Office guidelines.
