Pricing Model

NEC Rego operates a **transparent, scalable, and equitable pricing model** to support Integrated Care Boards (ICBs), NHS Trusts, and Primary Care Networks (PCNs) in commissioning and budgeting for implementation.

To ensure flexibility and future-proofing, NEC Rego has adopted a **per-patient pricing model**. This approach allows for seamless adaptation in the event of organisational changes, such as mergers or revised contracting structures.

Population-Based Pricing

Pricing is based on publicly available patient population data, ensuring consistency and verifiability. This data can be accessed via the NHS England Digital platform:

This model ensures all NHS organisations, regardless of size or structure, can access and scale the Rego platform in a cost-effective and sustainable manner.

Implementation and Training Price

Implementation, onboarding, and training costs are variable and will be scoped based on the following factors:

- Number of **referrer organisations**, for example Dental, Optometry, and Primary Care.
- Number of **provider organisations**, for example Secondary Care, Community, IMOS, and Private care.
- Number of **endpoints** within provider organisations.
- Number of **specialities and referral pathways**, including any localisation.
- Preferred **training format**, for example Train-the-Trainer or Super User formats.

A tailored quote will be provided based on the above criteria as per the SFIA Rate Card.

Speciality-Based Pricing

NEC Rego provides established solutions across multiple specialities, including Dental, Optometry, and General Practice. A **base price of 7p per patient** applies for standard, out-of-the-box configurations with minor localisation.

Any additional customisation or new referral pathways will be scoped and delivered on a **Time and Materials** basis as per the SFIA Rate Card.

The minimum contract value for any Rego Contract will be £50,00 excluding VAT.
