4. NCSC IT Health CHECK

IT Health Check (ITHC) services are charged at SFIA level 3 and SFIA level 4 from our Penetration Testing Consultancy Rate Card (section 11.2.1), which is £1,000-£1,100 per day.

ITHCs typically consist of various tests; we have outlined tests available below, along with associated days required. Buyers can define what tests they want, and how many, using these line items and the corresponding day rate.

5. Penetration Testing

Penetration Testing services are charged at SFIA level 4 and SFIA level 5 from our Penetration Testing Consultancy Rate Card (section 11.2.1), which is £1,100-£1,200 per day.

Penetration Testing might be performed on various systems; we have outlined tests available below, along with associated days required. Buyers can define what tests they want, and how many, using these line items and the corresponding day rate.
