### About the service





Discovery is the first phase in user-centred agile digital service delivery.

We conduct user research, technical investigations and collaborative workshops to understand:

- organisational goals, constraints
- users needs, motivations and barriers
- the priority problems to solve and potentially viable and sustainable solutions

Outcome: detailed, evidence-based recommendations on how to proceed.

# |Case study





In 2019-20, the private rented sector accounted for 4.4 million or 19% of households in England. In the Queen's Speech, the UK government committed to bringing forward reforms to drive improvements in standards in privately rented accommodation in England. A key point of focus was to support local authorities to conduct targeted, effective enforcement to drive out criminal landlords.

Between September and December 2021, Zaizi worked with DLUHC on a discovery to explore the merits of the introduction of a national landlord register in England. It began with collaborative scoping sessions to agree policy objectives, discovery goals and priority users. It also featured:

- qualitative and quantitative research conducted with local authority officers, landlords, agents and tenants/prospective tenants in the form of in-depth interviews, group workshops and a survey.
- exploratory sessions with a range of stakeholders, including industry bodies, representatives from the devolved administrations and colleagues from across government.
- technical feasibility testing to work out how a successful registration model might operate, and how it would integrate with existing data sources.
