# 1 PA CONSULTING GCLOUD PRICING DOCUMENT

## 1.1 Pricing Mechanisms

Our pricing mechanisms are set out below. Where they refer to a SFIA rate card, these can be found in the next section.

- **Time and materials**

### **Example fixed Price MVP: A 6-week (3-sprint) MVP of AI and process automation**

A team made up of the following skills and capabilities:

- Senior client account manager to oversee the work and manage the team
- Senior process expert acting as a 'product owner' to adapt processes to exploit AI and automation
- Automation engineer to focus on the process automation e.g. Microsoft Power Platform
- Prompt engineer for GenAI engineering e.g. chatbot, or query engine

To deliver a process MVP exploiting AI and automation that can be used as the base code and framework from which to scale into an operational service – example based on a Microsoft Azure based model.
