





Solutions to be customized based on targeted business needs


Business Continuity Plan

Mobility management consists of implementing tools to address the following needs:




Enterprise Mobility Management (EMM) is a service made of **one or several components** enabling organisations **to manage and secure mobile devices when used as professional tools.**






