AssetWise ALIM Services Pricing

Bentley's AssetWise Asset Lifecycle Information Management (ALIM) solution is sold via a commercial model based on business outcomes that tie cost to the value the user is achieving from the software services.

AssetWise Services, comprised of capabilities sets, are enabled through annual subscriptions. For each unique capability set, the software subscription service is priced by capacity within bands or levels based on not-to-exceed numbers of countable items. The correlation between value and capacity is such that the number of countable items reflects the value being realised from the software.

The asset-based pricing model is designed to allow a company to buy AssetWise ALIM and incrementally add other AssetWise capabilities as business needs dictate. The capacity band pricing applies regardless of whether the solution is deployed On-Premise or on Bentley cloud services built on Azure.
