For the Foreign & Commonwealth Development Office (FCDO) our experts provided project management, business analysis and a technical and security design authority services to assure the Consular business transformation strategy. This has involved projects supporting the Cabinet Office digital-by-default initiative and delivery of a number of significant global Cloud based services. This includes a new case management system that allows FCDO to support British Nationals involved in crises overseas. The system was developed using an Agile development approach, implemented on a new private cloud and accredited - all in under 4 months.

At a **Home Office Agency** our experts developed a secure portal to enable submissions to be made from different communities including a public facing channel. Each community was able to secure connect using a Public-Key infrastructure (PKI). Each external channel segregated but automatically connected through an external access service. It spanned 1 to 4 business impact levels and was assured and accredited to HMG Security Policy Framework. Our experts developed a high transactional database to support these channels, providing a means to prioritise and task each case submitted focusing the effort on the business activity and reducing the burden of managing this vast amount of information being gathered.

At the **Home Office**, our staff provided Project Management to help drive through the implementation of the Home Office £100m Extend and Blend desktop rollout project to 20,000 Home Office Staff, ensuring that revised delivery schedules were met and key business benefits delivered. This was recognised as one of the largest Citrix implementations of its kind in Europe.

Working with senior stakeholders within the **Identity and Passport Service** our experts provided project management and technical assurance on systems integration, enabling the repatriation of overseas passport processing back to the UK, significantly cutting costs and returning ownership of these processes back to IPS.
