PRICING FOR FINANCE ANALYTICS TIER I AND TIER 2

Pricing is determined by the expected number of reports requested over a 12-month period and the level of UK and Non-UK (International) reports.

The records then accessed via Finance Analytics is split into two buckets:

The Live Reports

Lists all the reports from countries that are considered "live". Live means data is automatically refreshed instead of buying a new report each time to get fresh data. To be added to this list a user must save the purchased report to their portfolio or added it to a folder. By default, the list will include the Country and Company (name, address, DUNS and registration number). Then the user can add up to 13 more D&B Live Report data elements.

The Portfolio Records

Lists all of the accounts and D&B Live reports listed as above. By default, the list will include the Account (name, address, DUNS and account #), Country and Company (name, address, DUNS and registration #). Then the user can add up to 12 more account and live report data elements. This list also represents the companies and accounts included in Portfolio Insight. The only exception is when a user manually selects an application to be excluded from their portfolio.
