A Principal Consultant will typically review:

- QA methodologies and procedures
- Documentation, standards, and templates
- Defect tracking systems, metrics, and KPIs
- Testing tools: management, automation, performance, API testing, security etc
- Test team composition and competencies
- Essential test stages, test and release schedules, and testing scope
- Development methodologies (e.g., Agile, Waterfall, Hybrid, V-model)
- Unidentified historical defects and their root causes
- Test Process Improvement (TPI) maturity level

On completion, we present a report of findings, which include prioritised recommendations on areas for improvement with suggested fixes. Industry standard benchmarks are also used to provide a formal measure of maturity of the test process.
