Methodology

Merging instances of JIRA/Confluence/Bitbucket has its challenges:

- Technical challenges: a merger often requires many considerations, such as the architecture of the platform (potentially a new platform), upgrades, clean-ups, integrations which will have to be rebuilt, etc.
- Organisational challenges: a merger poses challenges to governance and administration of the platform, ownership, freedom to make changes and impact of the changes on the users, etc.

Consolidations are complex projects, and so we apply a tried and tested **methodology** in multiple customer environments to ensure your consolidation will run smoothly. We work in two phases:

Application portfolio analysis

- Technical and functional analysis of each instance to be consolidated
- Mapping of risks and potential problems
- Benefit/risk analysis report across three dimensions: technical, financial, governance
- Target architecture recommendation
- Detailed project plan (charges / deadlines / costs)



Migration strategy development and Execution

- Data clean-up in source applications
- **Version upgrade** of the different instances to the target version
- **Migration** of configurations, data and projects on a test server
- Checking the consistency between source and target instances
- Switch to the production environment
