Report all your data consistently –

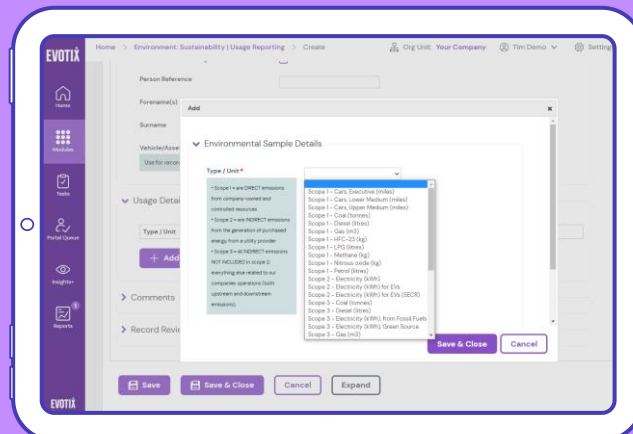
Configure forms to reflect your environmental reporting requirements, terminology and processes to collect consistent data across your company. Allow consultants and third parties to submit reports.
