

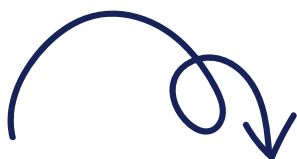

1. Evotix 360 Safety Management Package Pricing

G-Cloud 15 – 360 Services

The price of the Safety Management package is made up of three components listed below: the **Base Fee**, **Module License Fees** and the **Module Implementation Fees**:

360 FastStart – Base fee (fixed price, includes platform license and implementation of the elements detailed immediately below): £45,000 (+ fees per module/s selected, see further sections below for options).

- All fees exclude any applicable tax.
- This Base fee includes the following high-level tasks/deliverables.
 - Implementation of the Core Modules (Administration, Action Management, Document Register), Roam (mobile), Bi
 - Installation & Setup Single Sign On, if needed
 - Referential Data Imports (HR data, Reporting Hierarchies)
 - Training (via 'Train-the-Trainer' approach)
 - Export/Import Language Translations (up to 3 additional languages) *
 - Go-Live & Post Go-Live support
 - Project Management

Scoping/Design & Implementation Fees
