Storage

- The data storage is priced in hot storage at £27 per TB per month with a Play/Extract fee of £101 per TB.
- The data storage is priced in cold storage at £5 per TB per month with a £24 per TB retrieval to active.

AI Features Utilisation

The Solution provides a range of integrated AI-driven image/video analytics together with Bulk-Ingestion tools that can be configured and used by the client. There is no cost for using Innaxys' own AI processing that we have developed in-house, however the use of those functionalities does generate additional processing and storage costs that are chargeable at the rate of £ 0.65 per GB of data processed.

When there is a requirement to use a third-party AI model, an additional £ 0.06 per asset will be charged to account for the third-party charging model.

Where the data volumes become significant and require separate processing, we may deploy an additional environment with its own hosting in line with the main charging plan.

Services

| Onboarding

The standard onboarding covers the implementation services, including the cloud hosting configuration, the project management, the contract management, the testing and the activation of the service.

Additional services can be procured using the SFIA rates for customisation, interface development and other support activities.

| Training

The standard training proposed is based on our experience but can be customised with additional consultancy days.

| Licence

Licences are priced on a per user and per annum basis with a difference made between advanced users who have access to all functionalities, whilst basic users are mostly viewers or frontline.

| Support

The licence includes standard support on office hours between 9am and 5pm, Monday to Friday excluding public holiday.

A 24/7/365 support can be costed using the SFIA rates based on specific SLA requirements.

| Hosting

Hosting is priced on a per annum basis. The Solution will be hosted on AWS located in the UK meeting with daily backups.
