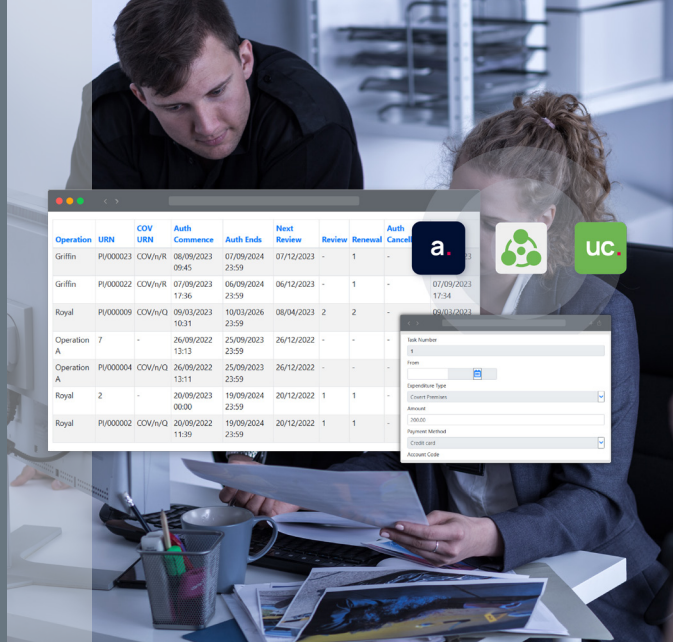

Why Undercover?

Central record

Appropriate authorisations

Legislative compliance

Use national forms for authorities, following the latest legislation providing compliance with RIPA and RIP(S)A 2000 with Criminal Conduct Act (CCA) amendments. Ensure the undercover officer is legally authorised for specific operational purposes and reviewed, renewed and cancelled in a timely manner.

Access control

Role-based access allows applicants, cover officers, COM-UCs and authorising officers to access only the applications they are responsible for, ensuring highly sensitive information is correctly recorded and force policy and legislative requirements are met.

Operational oversight

An operational synopsis links authorities, legends and subjects ensuring dates are tracked, avoiding over exposure of relevant sources to operational targets and CHIS. Manage financials incurred during an operation and other expenditure and expenses.

Information management

A secure and searchable database to manage all undercover activity with built in statistical and performance reporting and the ability to review, mark for retention or authorise for disposal in accordance with IPCO record and product management guidelines.
