HTG does not oversupply senior resources where they are not required.



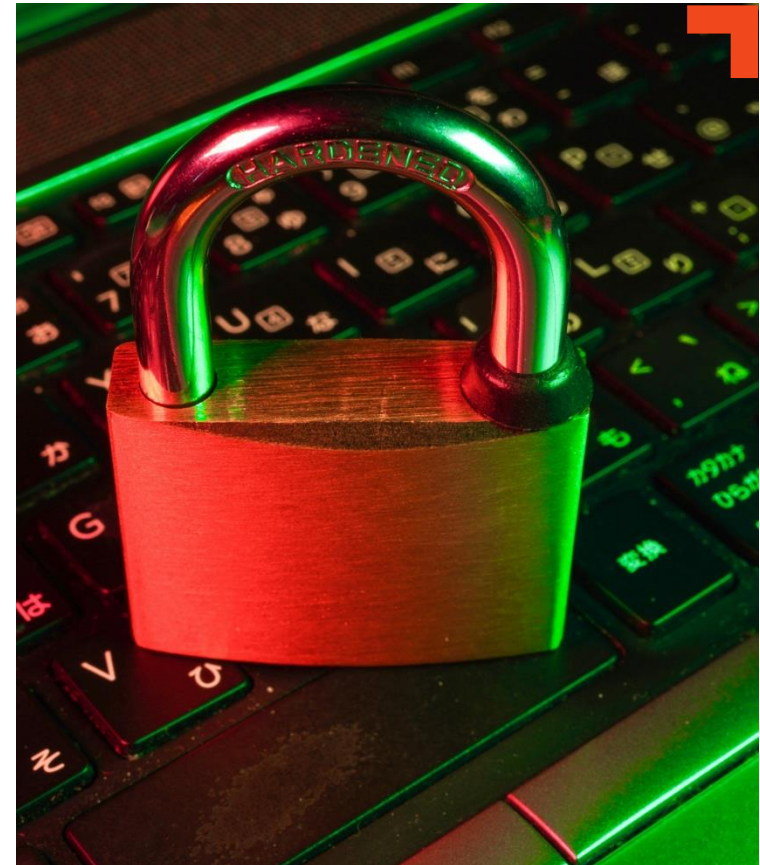
SECURITY LED DELIVERY MODEL

This approach reduces operational risk, avoids downstream remediation costs, and supports public sector organisations operating in regulated or high-assurance environments.



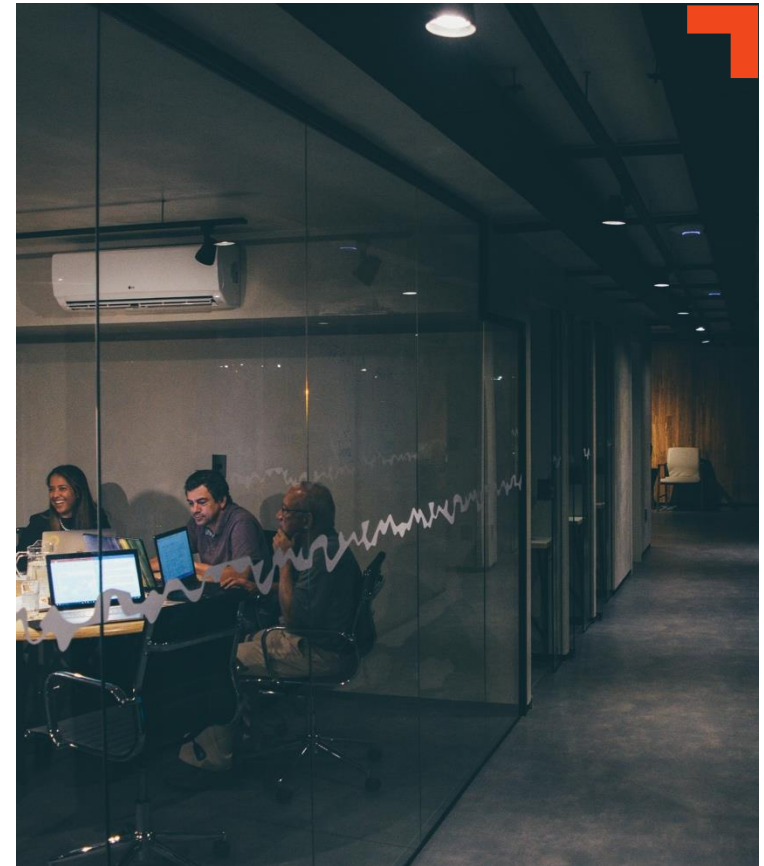
