- ▲ We have teams based in both the UK and Bulgaria – capability levels for SFIA grades are equivalent in both geographies. Availability of resources and teams from each location will depend on skills and capability required, resource capacity and any other constraints defined by the client.
- ▲ Pricing outlined above assumes a Time and Materials commercial model, based on units of resource required, daily rates outlined in the SFIA Rate Cards in this document, and, additionally, any agreed expenses.
- ▲ Additionally, we are prepared to adopt alternative commercial models linked to the value that we provide, and outcomes delivered, for example Balanced Scorecard, Fixed Price, Monthly Service Price and Risk-Reward.
