Real-time reporting provides visibility of commitments, accruals, and spend against budget, supporting effective financial management and accountability.

Panacea Purchase-to-Pay is designed to support high-volume, operational purchasing as well as lower-frequency, higher-value spend. It enables consistent treatment of routine, contract-based orders alongside ad-hoc and off-contract purchases, applying appropriate controls, approvals, and audit requirements in each case. This ensures flexibility for operational teams while maintaining financial discipline and organisational oversight.

Panacea Purchase-to-Pay integrates seamlessly with subscribers' finance or ERP systems to ensure consistency across supplier data, commitments, and invoice payment processing. Built-in exception management enables authorised users to handle non-standard scenarios without compromising control or compliance, ensuring the solution adapts to real-world operational requirements.
