Pricing Overview

This document sets out the pricing for the myRJ Restorative Justice Case Management Platform, provided by Connectivity Limited. Pricing is transparent, fixed, and suitable for direct award or further competition under the G-Cloud 15 framework.

Price Structure

Pricing is based on a per-tenant, per-annum licence, with unlimited agencies and users within the licensed area. Licensing is aligned to population size and operational geography to ensure scalability and value for money. There are no per-user charges.

Core Software Pricing

The myRJ Case management platform pricing is as follows;

Licence Notes

- One licence provides a single secure tenant.
- Unlimited users and participating organisations are included.
- Large metropolitan or multi-policing-area regions are licensed using multiple licences at a reduced rate.
- All prices are exclusive of VAT.

What's Included in the Licence Price

The annual licence fee includes:

- Secure UK-based cloud hosting
- Unlimited users and Agencies (organisations) within the tenant
- No case limits
- System maintenance and upgrades
- Security patching and monitoring
- Encrypted data storage and backups
- Standard reporting and data export tools
- Standard support service during core hours
- Data limits may apply for video storage

Assumptions

Pricing is based on the following assumptions:

- The buyer requires a single tenant unless otherwise specified
- Users access the service via standard web browsers
- Internet connectivity and end-user devices are provided by the buyer
