1. Overview

This document is intended to provide a pricing overview of Nine Software's ARC Form Builder critical incident information sharing platform. Please treat as "Commercial - In Confidence" not to be shared without prior written consent from The Nine Software Company Ltd (Nine).

Nine have a rich heritage in SaaS products that transform manual processes. We have built digital applications that processed the OVRO (also known as Foreign Nationals Registrations / Police Registration Scheme) and Firearms licensing activities within UK Police Forces. Nine rolled these hugely successful products out into 25 of the UK forces including the Metropolitan Police Service, Greater Manchester Police alongside several other notable forces.

Our ARC Form Builder platform carries on from those hugely successful applications, being designed to efficiently capture incident data from first and second responders and to efficiently process and use that data by making it readily accessible to others who may be contributing or taking over the case.

The platform has been designed by emergency workers for emergency workers, and with mobile apps compatible with both Apple and Android systems, it provides full flexibility over device choice for offline working and integration with patient monitors.

Incident data is now completely digitised with ARC Form Builder, so scene responders have all of the information they need in one simple-to-use dashboard. This digital interface can be accessed anytime, anywhere, giving access to crucial information while out in the field.
