Annual License Model (Unlimited downloads while contract in force)

Fair Usage Policy: Customer receives unlimited downloads of records/data as long as annual contract remains in force. If customer cancels contract early, fair usage charges apply retrospectively for volume downloaded beyond pro-rated allowance. Example: 12-process license cancelled after 6 months = pro-rated to 6 processes worth of downloads (50% of Fair Usage Volume). Any downloads beyond this are charged at fair usage rate.

Processes reflect the number of jobs/runs undertaken for the respective organisation

** Central Government is excluded and can be negotiated separately.*

Usage-Based Allocation: Customer purchases annual license with prepaid record allocation. Records drawn down as used during active contract. Additional per-record charges apply when allocation is exceeded. No retrospective charges if contract cancelled - customer has paid for their allocation.
